## Is my country open or banned?

See whether your country is currently classified as 'open' or 'banned'. The list and maps are based on the current number of infected people and are updated weekly by the SSI (Statens Serum Institut).

**Persons entering Denmark fall into one of the three following categories:**

### **Border regions**

Persons resident in Scania, Halland, Blekinge, Schleswig-Holstein or Norway can enter Denmark regardless of the purpose of their entry if the region meets the criteria for being classified as open.

### **Open countries**

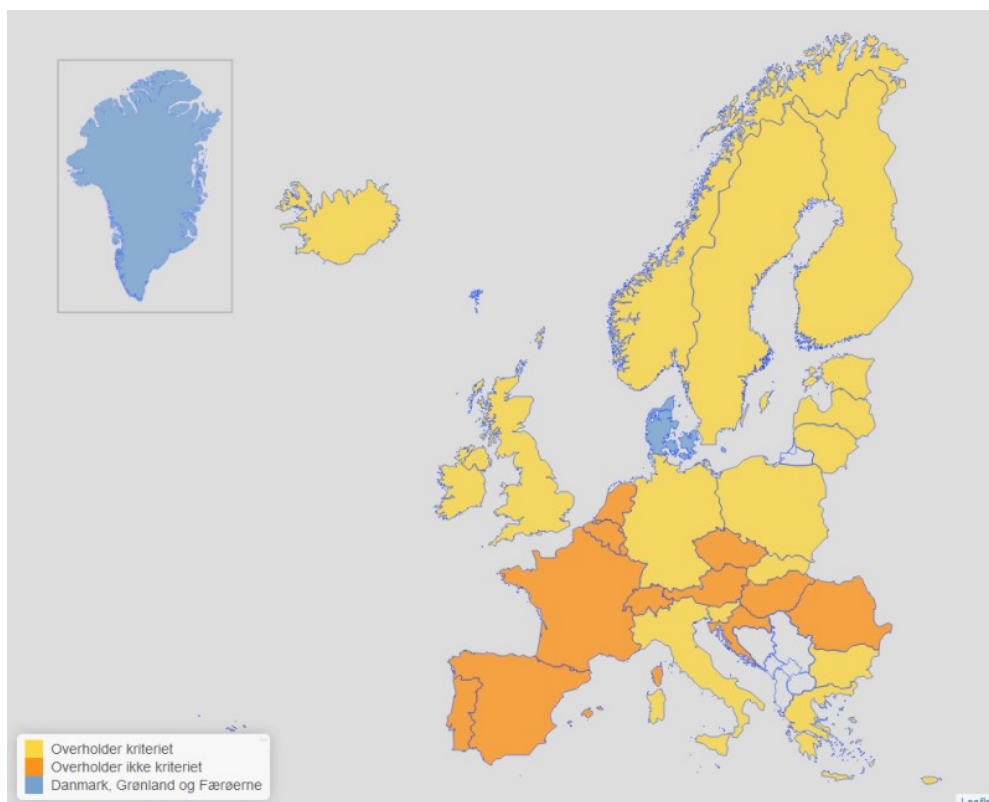
Persons resident in a country classified as 'open' (yellow) can enter Denmark, no matter the purpose.

### **Banned countries**

Countries (other than EU Member States, Schengen countries and the United Kingdom) are currently by definition 'banned' countries (orange). Third countries exempted from this ban are listed below under 'Other open countries'. Persons resident in a country/province classified as banned can enter Denmark if they have a worthy purpose.

**Applicable until Friday 25 September 2020 23.59**

**If your country is marked in yellow on the map, it is open:**



**Note the classification of small (or geographically small) countries that do not appear from the map and changes from the week 14-20 September 2020**

The Vatican City, San Marino and Cyprus are considered open countries. Andorra, Malta, Monaco, The Netherlands, Portugal, Switzerland, Hungary and Austria are considered banned countries.
